RE: Yellow Lake Solar Project

I'm writing to inform you of a solar energy project that is proposed to be located in the County of Forty Mile. The Yellow Lake Solar Project (the "Project") would occupy land within quarter section NW-13-8-12-W4 on Range Road 121, approximately 1.6 km south of Township Road 84 and 19km south of Burdett.

This letter is meant to provide some basic details about the proposed Project. If you'd like to find out more, we will be hosting a public meeting on November 24 to discuss the Project with local residents. We hope you will consider attending. The meeting details are below.

Project Description

The proposed Project is being developed by SunEEarth Alberta Solar Development Inc., which is jointly owned by BluEarth Renewables Inc. ("BluEarth") and SunEdison Inc.

The Project would generate up to 19 megawatts of electrical power that would be transmitted to the local electrical distribution system. This is enough energy to power more than to 3,100 homes annually.

The Project would consist of solar photovoltaic panels, panel racking systems, internal access roads, cabling, electrical inverters and other related electrical equipment. The Project equipment would be contained within a single quarter section of land. The exact location of the Project infrastructure within the property has yet to be confirmed and will be determined through additional studies, equipment procurement and engineering designs. The final project design within the quarter section will be communicated to residents once confirmed.

In addition, the Project will require the construction of a connection line to deliver power to the electrical distribution system. The connection line will consist of overhead electrical cables installed on poles along Range Road 121 which will link to the existing distribution line also on Range Road 121. The length of the connection line is expected to be approximately 800m. Please see the enclosed map for details.

BluEarth has consulted with FortisAlberta to confirm that the Project has the capability to connect to the local distribution system without compromising the quality of electrical service to customers. The Project will provide clean renewable power available to be used locally.

The Project will adhere to all setbacks (i.e. distance from roads and property lines) required by the County and therefore is not expected to have any negative effects on adjacent land usage.

Project Next Steps

The Project must receive several approvals before it can be constructed. These include:

- Alberta Environment and Parks – review and approval of wetland and wildlife studies
- Alberta Utilities Commission (AUC) – review and approval of a Rule 007 application

The Project schedule is as follows.

Participant Involvement Program

As part of the AUC approval process, BluEarth is undertaking a Participant Involvement Program (PIP) which is meant to engage local residents about the Project. The PIP will consist of this mailed notice, personal communications with landowners within 800m of the Project and a public meeting. For more information regarding this process, the AUC publication *Public Involvement in a Proposed Utility Development* has been enclosed.
